- **THE CLIENT** agrees that, in the event that any particular case has not terminated within one (1) calendar year from the **LIEN** implementation date, all outstanding Service Invoices for any, and all, particular case(s) that exceed the one (1) calendar year limitation will be due and payable to **BERTO** immediately and subject to a monthly three percent (3%) interest penalty fee until paid in full.

Agreement (for whatever reason) all outstanding invoices will be due and payable immediately.
